CARL HIGGINS

Carl Higgins, here, and today, we have Nicole White with us, via my Coverstory live video chat.

NICOLE WHITE

(THROUGH THE PHONE)
Hello, Carl.

CARL HIGGINS

Hello, Nicole. I assume that you have something for us.

NICOLE WHITE

(THROUGH THE PHONE)
Actually, I do not.

CARL HIGGINS

What? Oh really? Why is that?

NICOLE WHITE

(THROUGH THE PHONE)
Well, actually, talking about the Instigate Insurance year-end report, I can not say that it has told me anything new. It is not the complete report, I suspect. Not that this is the place for suspicions.

CARL HIGGINS

I think that our good reputation can hold up to a suspicion or two. Go ahead. I will tell you if you are wrong.

NICOLE WHITE

(THROUGH THE PHONE)
Oh, you will?

CARL HIGGINS

No. Everyone just needs to be aware that, while the situation is currently being looked into by the authorities, correct?

NICOLE WHITE

(DELAYED)
(THROUGH THE PHONE)

CARL HIGGINS

Okay. While the situation is currently being looked into by the authorities, nothing is clear at this point. We will give you all of the facts we know, but nothing is completely clear.

NICOLE WHITE

(THROUGH THE PHONE)

No. The police have taken over the investigation from here. What is interesting, though, is that they have been pressing Instigate Insurance for these same documents for nearly a week now. I was pressing for them for months before that. So, I am a little concerned now that they have suddenly been released.

CARL HIGGINS

Why...

NICOLE WHITE

(INTERRUPTING CARL)

(THROUGH THE PHONE)

The local police were working on getting a warrant to search through Instigate Insurance's records, all of the records.

CARL HIGGINS

Enough suspicious evidence was found to umm... warrant a warrant?

NICOLE WHITE

(THROUGH THE PHONE)

The idea was that a judge would be the judge of that, but it is very unlikely that a judge will grant a warrant to search for documents that have now been made public.

CARL HIGGINS

No, probably not. Have you read the entirety of the released documents yet?

NICOLE WHITE

(THROUGH THE PHONE)

Yes I have. And there was nothing in them to be concerned over, as I suspected when they were made public.

CARL HIGGINS

So, business as normal until something turns up?

NICOLE WHITE

(THROUGH THE PHONE)

That is what it looks like.

CARL HIGGINS

Well then, thank you for being here today. Get back to that usual business of yours.

NICOLE WHITE

(THROUGH THE PHONE)

You are welcome. I will.

(NICOLE HANGS UP)

SOUND: HANG UP NOISE.

CARL HIGGINS

So, an interesting mystery surrounds the Instigate Insurance annual report. That is what we have. I caution you to keep in mind, though, that neither the internal investigation, conducted by Nicole White, nor the ongoing police investigation have yielded any concrete conclusions, and although Nicole's internal investigation has brought up some questions, nothing is certain at this point.
